**WATER CHARGES**

<b>MINIMUM MONTHLY CHARGE ¾" meter</b>	23.00
1,000 gallons to 10,000 gallons	8.75/1,000
All water over 10,000 gallons	10.00/1,000
<b>MINIMUM MONTHLY CHARGE 1" meter</b>	46.00
1,000 to 10,000 gallons	12.00/1,000
Over 10,000 gallons	14.00/1,000
<b>MINIMUM MONTHLY CHARGE 2" meter</b>	65.00
1,000 to 10,000 gallons	17.50/1,000
Over 10,000 gallons	20.00/1,000

**CONNECTION & RECONNECTION CHARGES**

New ¾" Meter (on property where no previous meter ever existed)	2,500.00
New 1" Meter	3,700.00
New 2" Meter	5,700.00
Service Reconnection after being disconnected at the main water line	2,500.00
Long Side Road Bore	1,300.00

**SERVICE TO NEW LANDOWNER:**

A. If service was current and not delinquent in payments.	No Charge
B. If service had discontinued for less than one year prior to application by the Owner	50.00
C. If service was discontinued for more than one year prior to application by the new Owner	500.00

**NOTE: The foregoing does not relieve a new property Owner from paying any liens that may have been placed against the property due to nonpayment by the previous Owner.**

**RENEWAL OF SERVICE TO LANDOWNER:**

- A. If Landowner paid monthly minimum and all other charges and service was discontinued at the landowners request, there will be No Charge
- B. If the reconnection occurs less than one year after termination of service and the minimum bills were not paid the renewal charge shall be \$50.00 plus the payment of all past due bills, including penalties and interest
- C. If the reconnection occurs more than one year after termination of service, and the minimum bills were not paid, the renewal charge shall be \$500.00

**RECONNECTION AFTER DISCONNECTION FOR NONPAYMENT OF CHARGES OR VIOLATION OF RULES AND REGULATIONS:**

- A. If reconnection is made within one year of disconnection, the charge shall be \$50.00 plus payment of all past due bills, penalties and interest including monthly minimum bills.
- B. If reconnection is more than one year from disconnection, the charge shall be \$500.00 plus unpaid bills. There shall be no minimum monthly bill for past non-usage periods since the disconnection. By way of example, if the user terminated service with a past due water bill of \$350 and had no service for 13 months or more, the reconnection fee shall be \$350.00 plus \$500.00 reconnection fee.

**SERVICE TO RENTER:**

- A. A rental deposit is to be paid by all water users who are not the Owners of the property upon which service is sought. Deposit is \$100.00.
- B. If the property for which service is sought previously had service which was discontinued less than one year from reconnection, the charge shall be \$50.00 plus the deposit, plus all past bills, penalties, interest, and minimum bills must be paid before service is given to renter.
- C. If the property for which service is sought previously had service which was discontinued more than one year from reconnection, the charge shall be the \$500.00 connection charge plus the rental deposit plus unpaid bills. However, there shall be no minimum monthly bills during past non-usage. See the example given under paragraph B under Reconnection After Disconnection for Non-payment of Charges immediately above.
- D. If the property for which service is sought was not previously serviced the charge shall be the new meter connection charge plus the rental deposit.

**GENERAL:**

No Applicant for service who owes a past due bill shall be served at any location within the District until the past due bill is paid.
